# Background & Goals

- Support regional partnerships of local, regional, and tribal entities' regionalscale climate resilience solutions.
- Invest in two grant types: planning and implementation grants. Incorporate capacity building activities into both grant types.
- Round 1: \$9.4M Total



### Resilience vs. Adaptation

**Climate Resilience**: the capacity of any entity to prepare for disruptions, recover from shocks and stresses, and adapt and grow from a disruption.


**Climate Adaptation**: when natural or human systems adjust to a new or changing environment




Extreme Heat & Community Resilience Grant Program Adaptation Planning Grant Program (APGP)



# Key Program Priorities

- Fund regional projects
- Align projects with ICARP priorities to reduce climate risks
- Address the greatest climate risks in each region
- Support vulnerable communities



# Anticipated Impacts of the RRGP

- + Achieve a vision of collaborative resilience projects that reduce climate impacts in the near and long term
  - + New and existing collaboration
  - + Integrating local and traditional or tribal ecological knowledge
- + Support the full life cycle of regional resilience projects through planning and implementation phases
  - + Projects build capacity, focus on vulnerable communities, and support equitable outcomes

## **Community Feedback**

1. Provide flexibility in defining regions.

Allow self-identified regions.

2. Fund sustainable staffing and strategic partnerships to build capacity.

> Support staffing capacity to ensure multi-scale collaboration and prioritize vulnerable communities.

3. Streamline and simplify the grant application and reporting processes.

> Provide technical assistance and align with existing grant programs.

# **Regional Focus**

### 1. Regional Definition

- Regions may be selfdefined.
- Regions should share natural and built environment systems and climate risks.

### 2. Regional Partnership

- Regional partnerships required
- Multi-stakeholder partnerships with two or more jurisdictions involved.

# 3. Regional Diversity

 Fund at least one project from each of the California Climate Adaptation Strategy geographic regions.

# Grant Types

### **Planning**

for applicants who want to involve their community in studying and determining how to address climate risks in their region. Funds can assess regional climate risks, create regional plans for resilience, prepare for implementation, and more.

### Implementation

for applicants who already know some of the steps they need to take to address the climate risks in their region. Funds can support physical projects, like infrastructure, or nonphysical projects, like programs or processes, that reduce climate risk.

# Examples of Eligible Activities

### Planning

- Align plans for one or more climate hazards across multiple jurisdictions
- Conduct a regional-scale vulnerability assessment
- Form a regional climate collaborative

### Implementation

- Implement hazard-specific projects, like a wildfire fuel break project, sea level rise adaptation project, or a floodplain management project
- Implement existing state, local, or regional plans
- Implement a multi-hazard project, like a flood-after-fire project or an emergency response system

Note: This list is not exhaustive. More examples available in program guidelines.

# **Required Costs**

- <5% Peer-to-Peer Learning
- 3-15% Evaluation Activities
- <20% Administrative (Indirect) Cost Cap

# Eligible Costs

Ensure that costs proposed in the project budget are eligible for funding. More detail is available in the guidelines.

Planning & Implementation Projects:

- RRGP costs (Peer-to-Peer Learning, Evaluation Costs)
- Staff costs
- Travel costs
- Administrative costs
- Engagement, Outreach, Education and Training

#### Implementation Projects Only

- Direct costs
- Pre-development construction costs



#### **Eligible Applicants**

- Public Entities
- California Native American tribes
- Community-Based
  Organizations (CBOs)
- Academic Institutions

#### **Regional Partnership**

- Should involve two or more jurisdictions
- Varying partnership requirements depend on the Lead Applicant type

## Partnership Requirements

#### California Native American tribes

Apply with at least one other California Native American tribe or public entity in another jurisdiction

#### **Public Entities**

- Apply with at least one CBO and
- Apply with at least one public entity in another jurisdiction or at least one California Native American Tribe

#### Community-Based Organizations (CBOs)

Apply with at least two entities (California Native American tribes or public entities) representing different jurisdictions.

#### Academic Institutions

- Apply with at least two entities (California Native American tribes or public entities) represent ing different jurisdictions and
- Apply with at least one CBO

## Priority Communities & Set Asides



- At least **51%** to projects that serve disadvantaged communities
- At least 10% to projects that serve California Native American Tribes
- At least one project from each of the nine geographic regions defined by the California Climate Adaptation Strategy
- Fund at least 2 projects to establish tribal and rural regional partnerships

# Activities

### Eligible

- Activities should have a regional focus and align with one of the RRGP Goals
- Stronger projects will also be consistent with at least one climate-related state plan

### Ineligible

- Legislative lobbying and lawsuits
- Environmental studies, plans, or documents normally required for project development under the California Environmental Quality Act (CEQA) or National Environmental Policy Act (NEPA)

# **Application Process**

- **1. Intent to Apply** 
  - Purpose:
    - Evaluate applicant eligibility and potential for regional collaboration
    - Direct resources for technical support or other funding opportunities
  - Will accept submissions on a rolling basis until applications are due
  - Prospective applicants should fill out, to the best of their ability, details about the project and applicants

# **Application Process**

### 2. Application Submission

- Virtual application submission through SharePoint Grants Portal
- Application Workbook includes an Applicant Summary, Work Plan, and Budget
- Narrative questions align with topical areas in the Scoring Criteria
- Additional documentation:
  - Proof of Alignment with Relevant Planning Processes
  - Community Engagement Plan (Optional)
  - Letters of Support (Optional)

# Scoring Criteria (100 points possible)

- 1. Project Description & Goals 15 points
- 2. Community Partnership, Needs & Priorities 20 points
- 3. Climate Risks & Multiple Benefits 20 points
- 4. Regional Partnership 20 points
- 5. Organizational Capacity 10 points
- 6. Budget 15 points

# Project Description & Goals (15 points possible)

### **Project Description**

- Clearly describe project eligibility for RRGP
- Demonstrate alignment with relevant plans, programs, and policies

#### **Who the Project Serves**

- Define target audience and beneficiaries
- Identify vulnerable communities as primary beneficiaries

#### **Expected Project Outcomes**

- Describes short- and long-term outcomes
- Align with application components and goals

### Work Plan

 Detailed work plan with clear timelines, tasks, and deliverables

# Community Partnership, Needs & Priorities (20 points possible)

### What the community's needs and priorities are

- Describe community's needs and priorities
- Address current inequities and building resilience and capacity

### Who identified the community's needs and priorities and how

- Describe who identified the needs and priorities
- Show a meaningful, and inclusive community engagement process

### How the community's needs and priorities informed the project design

- Describe the community involvement in defining and designing the project
- Demonstrate strong community support

### The project's community partnership and engagement plan

- Describe the project's diverse community partnership structure
- Show the project includes vulnerable communities & considers accessibility

# Climate Risks and Multiple Benefits (20 points possible)

#### The region's greatest climate risks

- Describe current and future climate risks
- Align greatest risks with RRGP focus areas (drought, flood, extreme heat, etc.)

### Whether the application addresses the region's greatest climate risks

- Demonstrate how the project specifically addresses climate risks
- Demonstrate maximized resilience and address multiple risks

### Methods the project will use to address the climate risks

- Evaluate resilience opportunities during project design
- Apply systems-level thinking, problemsolving, and climate projections

#### The multiple benefits the project offers

- Demonstrate comprehensive community benefits, prioritizing vulnerable communities
- Show benefits beyond climate resiliency, spanning sectors and addressing climate issues

### Regional Partnership (20 points possible)

#### The regional partnership structure (i.e., applicant and co-applicants)

- Demonstrate how the diverse partnership will result in effective response to climate risks
- Include capacity building for partners that represent vulnerable communities

#### Partner responsibilities and long-term goals

- Commit to equity, self-governance, sustainability, and timely implementation
- Explain how you will evaluate progress, use findings, and collaborate meaningfully

### Organizational Capacity (10 points possible)

#### **Administrative Experience**

- Demonstrate ability to manage grants, coordinate diverse partners, and ensure financial tracking and accountability
- Demonstrate commitment, readiness, and capacity of regional partners for timely and budget-conscious implementation

#### **Programmatic Expertise**

- Commit to equity, self-governance, sustainability, and timely implementation
- Explain how you will evaluate progress, use findings, and collaborate meaningfully

#### **Plans to Meet Capacity Gaps**

- Describe strategies to close capacity gaps
- Reflect sustainable staffing levels for capacity building

### Budget (15 points possible)

#### Align with the RRGP

- Only include eligible costs based on RRGP Guidelines
- Allocate 3-15% for Evaluation Activities and up to 5% for Peer-to-Peer Learning

#### Align with the project goals and work plan


- Include reasonable tasks, deliverables, and consider the grant timeline
- Align budget with project goals and activities

#### Be detailed and complete

- Outline proposed activities by task and line item and allocate responsibilities and resources across co-applicants
- Demonstrate understanding of proposed activities, partners' strengths and experience, and include supporting justifications


#### About this group

- Guides implementation and holds partners accountable

- Progress reports
- Regular check-ins
